

Meeting Minutes January 9, 2017

Call to Order: 4:35 pm by President Tim Ricketts, who led the Pledge of Allegiance, and called for introductions.

Approval of Minutes: December minutes were emailed to members prior to the meeting and printed copies were available at the meeting. A typo was pointed out and will be corrected. Tim called for motion to approve December meeting minutes as amended. Sandy motioned. Mark 2nd. Motion carries.

Treasurer's Report: January Treasurer's Report was emailed to members prior to the meeting and copies were available at the meeting. The checking account balance is \$3020.34. Two \$75.00 checks were written to CGTI for two RAD students to attend the 2017 Mid-Year Conference on Saturday, January 15-Sunday, January 16, 2017 in Normal, IL, with several Wilmington HS YCAT students. The undesignated funds balance is \$687.69. The designated funds balance is \$2332.65 with \$1142.56 available in HEAR US, \$274.00 in BASSET, \$416.09 in CDAE, and \$500 in YCC. Tim called for motion to approve January Treasurer's Report as presented. Janie motioned. Nick 2nd. Motion carries.

Sandy mentioned that it may be prudent to have an external audit performed. Sarah said she would check with Brenda Anderson.

Action Team Reports & Partner Updates:

C.H.A.N.G.E. Program (Communities Helping Addicts Needing to Gain Empowerment) -

- 10 clients have been placed
- More placements are being handled on our own
- New partner agencies are being sought
- Crisis intervention training for CHANGE agents (and PD officers) is in the works
- Availability list for CHANGE agents is being organized
- Sarah is working on a procedure manual

- Chief will be talking about the CHANGE Program at the Anti-Stigma conference at JJC on April 21st
- Plans are in the works to invite Chief Langlois from Dixon and Tim Ryan to speak to other PDs about starting similar programs in their communities
- Janie recieved a letter from a placement that will soon be completing the inpatient program at Haymarket
- We are looking at a 60% success rate
- Being able to offer a support group when clients return from treatment is essential to their recovery

SMART Recovery - Denise reported that she had two people attend the last meeting. (Slow but steady winds the race!)

RAD (Reed-Custer Against Drugs) - 2 students will be attending CGTI's Mid-Year conference with several WCHC YCAT youth group members on Jan 15 & 16th in Normal. They will share with us when they return. They are planning activities for National Drug & Alcohol Facts Week. Tim is planning for a joint meeting with the RAD students, the WHS YCATS, and the PHS TAD students sometime in the future.

EYPC/Reality IL - Amrita reported that 12 signs were put up at the Braidwood Park District's parks (No Tobacco Use at Kiddie Parks and Tobacco Free Zones at Braidwood City Park). The Health Department placed a thank you ad that ran in the Braidwood Journal. Now that these zones have been established, no more initiatives are scheduled in Braidwood. The Reality IL educators have talked to the TAD students in Peotone & will be working with them to establishing Tobacco Free parks in Peotone.

PRADA - In order to promote PRADa in Peotone, they are working with Catherine Rook of Sertoma Centre to schedule Mental Health First Aid Training in March for their first responders and community members. Cahterine will be discussing the program at the PRADA meeting on January 19th.

Guest Speaker: Niki Perry, a certified mental health counselor & physical fitness trainer and owner of 515 Fitness in Coal City spoke about the revolutionary Mental Health program they offer to people of all ages at her facility, which is open early in the morning til late in the evening to meet client's needs. In addition to counseling, her staff stresses the practice of good habits (exercise) and good nutrition in the treatment of mental health and substance abuse. Clients they have served range from age 1 - 83. The staff will set up a treatment plan with each client and submit bills to their insurance. Niki noted that they will not turn anyone away, regardless of insurance. Information was distributed to members.

WCHC - President Paual Ekstrom reported on what is happening with the Wilmington coalition.

- Plans are is the works for the first Post Prom for WHS Students. The project is being spearheaded by FCC with assistance from other local churches. The new WHS principal was involved in PHS's post Prom, so has many great ideas.
- The YCAT group worked on the alcohol Town Hall Meeting that was recently hed in Wilmington.
- Training is scheduled for the new drug dog in Wilmington.
- The WCHC Board and staff are finalizing their semi-annual DFC report.
- The Lions Quest program will be implemented at Bruning School (pre-K & 1st grades)
- Parent meetings will be held in conjunction with the Lions Quest programs.

Illinois National Guard Counterdrug Task Force - Sgt Lacy reported that they have icreased manpower to serve coalitions on a one to one basis throughout Illinois by training their data analysts to work with coalitions. She introduced Evan Westart, who is based out of Kendall County, as our new liaison.

Project Coordinator Updates:

CADCA Leadership Forum - Pete will be attending CADCA"S Leadership Forum in Washington, D.C. on Feb 6-9 with several members of WCHC.

SPF Grant Award - Pete reported that the state has awarded an additional \$4000 to our SPF grant to be utilized for capacity building, programs and campaigns as are indicated in the grant. Ideas for spending down this extra award might be to offer a post prom prize, and for prinitng of coalition brochures.

CADCA Member Education Articles - Pete distributed the following member education articles from CADCA: "Combating Creative NHTSA Virtual Game Encourages People to Drive Sober During Holiday Seasonand Always", "2016 Monitoring the Future Highlights", "Walgreens Expands Availability of Naloxone without a Prescription to 33 States and D.C." He also provided an article from the Naperville Sun: "Heroin-related deaths up 42% in 2016 in Will County; Dupage numbers still out".

Website - Pete reported that several propsoals have been received and the selection of the contractor is being handled by Chestnut.
